Pursuant to the Office Memorandum No. F. N. I-11012/1/2009-ISI (pt.2) dated 26<sup>th</sup> June, 2013 issued by Ministry of Statistics and Programme Implementation, Government of India, telephone reimbursement facility to the following categories of Institute officials is being introduced with effect from 1<sup>st</sup> July, 2013 in line with the Department of Expenditure, Ministry of Finance, Government of India guidelines issued vide O.M. No. 7(14)/C&V/2006 dated 14<sup>th</sup> November, 2006 and subsequent OMs issued in this regard:



Terms and conditions for reimbursement of the above will be governed in the following manner:

- (i) The amount will be reimbursed within the prescribed ceiling on submission of bill / receipt by the concerned official. There will not be any separate ceilings for landline / mobile / Broad-Band / Internet facility through Data Card.
- (ii) The amount reimbursable will cover landline, mobile connection and Internet facility through Broad-Band / Data Card.
- (iii) The amount reimbursable is exclusive of all taxes, if any.
- (iv) Officials are at liberty to choose the service provider and avail any options for payment within the maximum monetary ceiling.
- (v) It will also include Broad-Band / Internet facility through Data Card or such facilities through which data voice or image is transferred.
- (vi) STD facility may be provided in the residential telephones. However, there would be no enhancement of ceilings as prescribed above.
- (vii) No instrument, henceforth, would be provided by the office, except to the Director, for which the cost of handset for mobile phone would be limited to Rs.10,000/- in each case.
- (viii) The amount reimbursable will be reduced by Rs.400/- if the official with Grade Pay of Rs.7,600/- and above does not have Broad-Band / Internet facility through Data Card at his/her residence.
- (ix) All the offices are instructed to bear the extra cost from their 'Telephone Expenses' (Non-Plan Account No.404).


