
**OFFICE MEMORANDUM**

Sub : Grant of Dearness Relief to the Recipients of Ex-gratia payment @ Rs.600/- & Rs.605/- per month of the Institute. Revised rates effective from 01 July 2011 & 01 January 2012.

A reference is invited to this Office Memorandum No.C 317/RBC dated 20 May 2011 on the subject cited above. Pursuant to the decision of the Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners' Welfare, as communicated in their O.M. F. No.42/15/2011-P & PW (G), dated 21 October 2011 & O.M. F. No.42/13/2012-P & PW (G), dated 30 April 2012, which have been received from the Nodal Ministry (MoS & PI) vide its letter bearing No.B-12034/2/2012-Coord dated 02 July 2012, **the rates of Dearness Relief payable to the Recipients of Ex-gratia payment @ Rs.600/- & Rs.605/- per month of the Institute will be enhanced at the rate(s) mentioned below with effect from 01 July 2011 & 01 January 2012 respectively.**

2. The surviving CPF beneficiaries who have retired from service between the period 18.11.1960 to 31.12.1985 and are in receipt of Ex-gratia @ Rs.600/- per month with effect from 01.11.1997 in terms of Institute O.M. No.C2529/RBC dated 01.07.1998 are entitled to Dearness Relief @ 127% with effect from 01 July 2011 and @ 139% with effect from 01 January 2012 respectively.
3. The category of CPF beneficiaries who are in receipt of Ex-gratia payment of Rs.605/- per month in terms of Institute O.M. No.C2529/RBC dated 01.07.1998 are entitled to Dearness Relief @ 119% with effect from 01 July 2011 and @ 131% with effect from 01 January 2012 respectively.
4. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
